

**Town of Green Lake  
Regular Town Board Meeting  
Monday, April 10, 2023**

Notice for this meeting was given by posting at the Town Hall and the Town's website.

Chairman Moderow called the regular town meeting to order at 7:00 PM. All board members were in attendance. There were 7 citizens in attendance.

Motion was made by Berndt/Zick to approve the agenda. Motion carried.

Tony Goebel came to introduce himself. He purchased Rose's restaurant on Little Green Lake.

Motion was made by Berndt/Zick to approve the minutes from the regular monthly meeting on Monday, March 13, 2023. Motion carried.

Motion was made by Moderow/Berndt to approve the vouchers/bills. Motion carried.

**Treasurer's Report** – Treasurer Machkovich's report was reviewed. No transfer needed at this time. A motion was made by Berndt/Zick to accept the report. Motion carried.

**Maintenance Report** – Dan reported that piers were put in today. The older mower is ready to go but the new one hasn't shown up yet. Winter equipment will be taking off this week. Pallet forks would be a good thing to get too. Also mentioned the overhead doors when they will be looked at. Motion made by Moderow/Berndt for Dan to get some pallet forks. Motion carried.

**2023 Road** – Lucas from General Engineering Company attended the meeting to discuss the Blackbird Point Drive reconstruction project this summer. They sent out for bids and received two bids. The lowest bid was from Kartechner Brothers for \$192,270.50 and Northeast Asphalt, Inc. came in at \$227,393.00. GEC also made sure there is a deadline by October 15<sup>th</sup> to have the work finished – black-top done by October 1<sup>st</sup>. They plan to start in August. Motion made by Zick/Berndt to go with Kartechner for \$192,270.50 for the road construction of Blackbird Point Drive. Motion carried. Chairman Moderow discussed what other roads they could use the other road construction funds. They will be meeting with Scotts Construction on Monday. We will bring this back at the May meeting.

**Little Green Lake** – Chairman Moderow took this off the agenda at the meeting.

**Approval Mobile Home Park License(s)** - Motion made by Berndt/Zick to approve South Shore and Shady Oaks mobile home park licenses. Motion carried.

**Tax collection agreement (Transcendent)** – Lindsey went over the agreement. Motion was made by Moderow/Berndt to sign the agreement with Transcendent for our tax collection agreement starting this December. Motion carried.

**Town Insurance policy renewal** – Chairman Moderow noted that the amount did not change.
