The amended 2023 budget hearing was called to order at 6:45 p.m. by Supervisor Berndt. Chairman Moderow was absent. There was 1 elector from the Town present. The 2023 budget summary was available for viewing.

Motion was made by Berndt/Zick to approve the amended 2022 total town Levy to be collected in 2023 for the Town of Green Lake in the amount of \$618,931. Motion was made by Zick/Berndt to approve the 2023 Town of Green Lake budget & the 2023 Highway budget. Motion carried.

Maintenance Report – Dan reported that the winter equipment is all mounted. He has cleaned up a lot of trees around the township. Also cleaned up some trees at Phelps. Did winterize all the fuel. Did some brush burning too. All set for winter.

Hauler License Approval – GFL and Waste Management had paid their dues for their Waste Hauler license for the year 2023. Motion made by Berndt/Zick to approve the licenses. Motion carried.

Town Caucus Date: The date has been set for Monday, January 9, 2023 at 6:30 prior to the regular meeting. Motion made by Berndt/ Zick. Motion carried.

Phelps Account: The court date is set for December 21, 2022. Chairman Moderow will attend. The court hearing is just a standard trust thing to see how the funds are being spent and if there is an opportunity to broaden the spectrum of how its utilized.
