We will open a sub account for the American Rescue Plan Act grant we will be getting this month in the amount of \$61, 283.44. Motion was made by Berndt/Moderow. Motion carried. Zick/Moderow made a motion to transfer \$30,000 from Phelps to Equipment account. Motion carried.

Maintenance Report: A lot of shouldering and starting mowing ditches this year. County is going to start spraying some areas. Dominic has done some tree trimming in Phelps and other around the township. He also ordered some culverts, could be 6-8 weeks and the price will be higher than last year.
