

Town of Green Lake - Regular Town Board Meeting
Monday, June 8, 2026

Notice for this meeting was given by posting at the Town Hall and the Town's website.

Chairman Moderow called the regular town meeting to order at 7:00 PM. All board members were present. There were 2 citizens in attendance.

The motion was made by Strelow, seconded by Berndt to approve the agenda. Motion carried.

The motion was made by Berndt, seconded by Strelow to approve the minutes of the regular monthly meeting on May 11, 2026. Motion carried.

Motion was made by Moderow, seconded by Berndt to approve the vouchers/bills. Motion carried.

Treasurer's Report – the board members reviewed the report. There were \$19,463.94 credits and \$178,082.63 debits. Reported balances on Money Market, CD and Phelps Savings Account. Motion to approve Treasurer's report and the transfer of \$27,337.50 to the general account for the payment of bills. Motion made by Berndt, seconded by Strelow. Motion carried.

Maintenance Report – was reported that they went through almost 4 tons of cold mix doing road repairs. Need to get some more for the large dip in the intersection of Fiefel & Utley Road. Trying to get answers for the wash out on Welks Landing. The culvert on Fiegel Road rotted out on the bottom causing damage to the shoulder. The road is still good. The yellow lines will be painted and touched up this month per the weather. The only roads being mowed are the ones the county did not spray. Three - 30 yard dumpsters will be delivered on Friday, June 12th for the bulk waste pick up. They will be the low profile dumpsters. A lady called about controlling a Japanese knot weed on her property. I will cut it out in the ROW but not on private property. Cracking filling update is that the county is behind and wouldn't be able to be here until October.

Cemetery lot pricing – A discussion was held about making the pricing all the same. Motion was made by Berndt to have the pricing at \$250.00 per lot. Motion seconded by Strelow. Motion carried.

2026 Road bids – Chairman Moderow talked with Lukasz and he needs another week for bids. Fahrner bid for McAfee Road, Boelter Road, Utley Road won the bid. Scotts bid for double chip seal on Fiegel Road. Thomas Road might wait for next year. Motion made to accept the bids for the road construction made by Strelow and Second by Moderow. Motion carried. Also, a motion made by Strelow/Moderow to accept the bid for the Fiegel Road culvert for \$5,500.00

In the designated premises includes a food truck, tiki bar, temporary event tents, boat slips, and portable serving bars. Storage of alcohol overnight is to be inside the locked tiki bar storage, or food truck, then brought out to portable serving bars inside the premises for sale and consumption. **There is a 10x20 shed on the parking lot side used for the storage of alcohol. ** The existing building at N2811 Park Road, Markesan, WI is a completely unlicensed hotel facility with no sale, consumption, or storage of alcohol using Class B liquor or beer licenses.*
