Regular Town Board Meeting
Monday, March 13, 2023

Notice for this meeting was given by posting at the Town Hall and the Town's website.

Chairman Moderow called the regular town meeting to order at 7:00 PM. Treasurer Machkovich was absent. There was 1 citizen in attendance.

Motion was made by Berndt/Zick to approve the agenda. Motion carried.

Motion was made by Berndt/Zick to approve the minutes from the regular monthly meeting on Monday, February 13, 2023. Motion carried.

Motion was made by Moderow/Berndt to approve the vouchers/bills. Motion carried.

Treasurer's Report – Treasurer Machkovich's report was reviewed. A motion was made by Moderow/Zick to accept the report. Motion carried. Chairman Moderow will remind Lindsey to transfer the \$50,000 into the town equipment and \$25,000.00 into the fire department for the 2023 Budgeted amounts.

Maintenance Report – Dan reported they took a tree down at Horicon landing and going to grind the stumps this spring. In Grand Prairie Cemetery someone drove a skid loader in there and he will have to fix the ruts and will bring dirt to fill the ruts. The new ramp made for Horner's. He will put the weight limits on the road on Monday. The mowers have been serviced.

Annual meeting date – The annual meeting date will be the 3rd Tuesday of April at 7:00 PM.

Bulk Trash date – The date is set for Saturday, June 10, 2023 at 7:00 AM until noon. Dan will be contacting Kinas for the dumpsters.

Liquor license approval – The board approved the liquor license for Little Adventure Vacation Rentals LLC. Motion made by Moderow/Berndt. Motion carried.

CUP County Zone Request (Anthony Goebel) - The board approved the CUP County Zone Request. Motion made by Moderow/Berndt. Motion carried.

Wood Chipper – City of Markesan – Chairman Moderow contacted Todd Zamzow at the city and spoke with Rich also. The town approved to pay the \$2,500 to the City of Markesan, but the Town of Green Lake will not be liable if someone breaks the machine. Chairman Moderow will get this in writing prior to sending a check. Motion made by Moderow/Berndt. Motion carried.

New website discussion – Motion by Moderow/Berndt to go with Vision Design for a new website. Motion carried.

Election Workers Pay – Election workers \$18.00 for chief inspector and \$16.00 for poll workers as of 4/4/2023 election. Motion made by Berndt/Moderow. Motion carried.

2023 Roads – Chairman Moderow spoke with the engineer who is looking at Blackbird Point. The engineer will take care of all the posting and bids. He plans to be at our April meeting to discuss bids and other road information. Chairman Moderow will check on Lakeview and Sandstone bids/roads.

Boat Launch Fee(s) – Chairman Moderow has had a few phone calls about who is enforcing the stickers and landing fees. The board may need to look into this.
